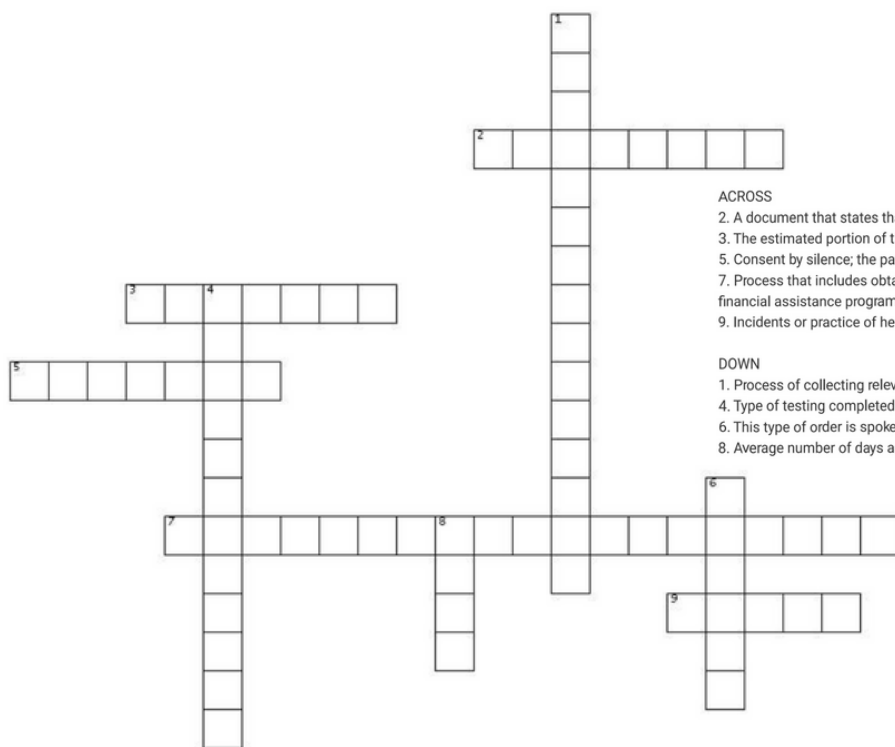


PRESIDENT'S LETTER

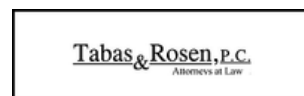
